



Covid Information for attending lessons and Consent Form

Things are different everywhere and dance is no different, I have completed a risk assessment in line with the government close contact guidelines which we all must adhere to. Please read through the new procedures and discuss them with your child prior to their first class, also complete the Covid 19 Form and return before first lesson.


Procedures for attending lessons.

1. Children should be dropped off to dance lessons to the outside door of the building following the one way system in place to and from the studio. Parents must not enter the building. Where absolutely necessary a face mask must be worn and hands sanitised.
2. Parents are not permitted to wait in the building, or interact with other parents in the hallways blocking exits. If a parent wishes to wait they must do so outside the door.
3. Children must arrive to dance class fully dressed in AGSOD uniform. No changing facilities are available at this time. A partition screen will be available in the studio if absolutely necessary.
4. All children should wear dance shoes at all times. No barefoot dancing will be allowed.
5. All children should arrive to dance with all hair tied securely back, none hanging free.
6. Each child should have a labelled water bottle and if required a labelled yoga mat, these should be left in designated areas in the studio during class.
7. On arrival at dance, pupils should wear their masks and wait in a line at social distance outside the studio. Once inside the studio face masks can be removed and hands must be sanitised before standing on their area.
8. In class we will be working at a social distance as and where possible, pupils must adhere to this and stay on their designated area.
9. On leaving class, pupils will sanitise and wear face masks before leaving the studio. Once in the hallway they must follow the one way system in place and leave the building before interacting and removing masks.
10. There will be a toilet designated for AGSOD, for pupils use only.
11. There will be 10 minutes between classes to wipe down the studio.
12. If you wish to discuss your child with Amber please do so by phone in the morning between 10-1pm, not during class time or wipe down time.
